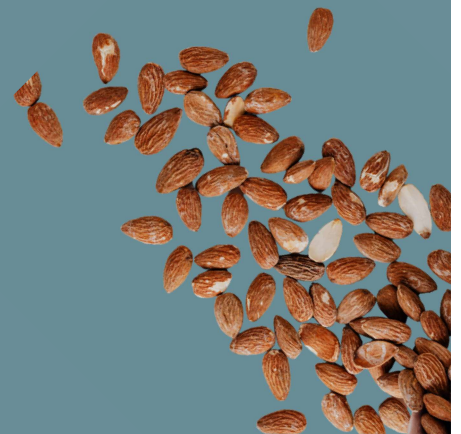

TERMS AND CONDITIONS:

1. **PLEASE** contact our office if you do not receive your catering agreement, banquet orders, and balance due within **(14)** days of placing your order; receipt of these forms **CONFIRMS** your order has been placed.
2. Full payment must be received **(7)** business days prior to the start of services (checks and/or wire transfers must be received **(10)** days prior); all replenishment orders during the show must be guaranteed by credit card; any balance of charges due will be billed to the credit card on file.
3. Orders received within **(12)** business days of the event will incur a 40% late fee. Orders will be fulfilled based on availability.
4. Additions/Increases for the next day must be requested by **12 PM EST the previous day** and will incur a 40% late fee. Orders will be fulfilled based on availability.
5. **Cancellations/Decreases require 48-hour notice; however, you will still incur all charges.**
6. **Actual service delivery times may be one hour prior to your requested delivery time.**
7. All disputes or complaints relating to our services under this Agreement must be submitted in writing within seven (7) days after the event. Client's failure to notify us of any dispute or complaint, as detailed herein, shall constitute a waiver.
8. 24% Service Charge, 8.9% Sales Tax, and 3% City Liquor Tax (where applicable) will be added to the total.
9. If the food/beverage order is less than \$250.00 per delivery, a \$100.00 service fee will be assessed to the catering order.
10. If purchasing alcoholic beverages, the undersigned agrees to comply with all applicable laws regarding the use, sale, serving, or other disposition of such alcoholic beverages. Accordingly, the undersigned agrees to indemnify and forever hold harmless Levy Restaurants and the GWCCA from all liabilities, damages, losses, costs, or expenses resulting directly or indirectly from the undersigned use, sale, serving, or other disposition of such alcoholic beverages.
